

POTOMAC EDISON'S INSTANT LIGHTING DISCOUNTS CUSTOMER FAQs



- 1 Is my business eligible for the Instant Lighting Discount?** All Maryland Potomac Edison commercial and industrial customers are eligible for the Instant Lighting Discount.
- 2 How does the Instant Lighting Discount work?** When you purchase a qualified lighting product from a participating distributor, the cost of the item will be instantly reduced by the predetermined discounted value of that specific product. Purchase price, minus the discount, equals the discounted purchase price.
- 3 What types of lighting products are eligible for the Instant Lighting Discount?**
 - LED Type A-lamps
 - LED Specialty lamps, Type MR, BR, PAR, R, decorative and globe
 - LED High and Low Bay fixtures
 - E39 mogul base lamps
 - LED Linear fixtures and retrofit kits
 - LED Linear tubes, Type A LED
 - LED Exterior wall pack and floods

Lighting products must be listed on DLC 4.3 or ENERGY STAR® 2.1. Visit energysavemd-business.com or consult a participating distributor to see what products they can offer.
- 4 Where do I find a participating distributor?** A list of participating distributors is available on the program website at energysavemd-business.com.
- 5 Can I purchase products using the Instant Lighting Discount and then submit an application for an incentive?** No, if you choose to use the Instant Lighting Discount, then your project is not eligible for additional incentives using the regular incentive process.
- 6 What will I need to provide to the distributor to get the Instant Discount?** You will need to provide your Potomac Edison account number, the name and address of the business where the products will be installed, and some contact information.
- 7 How do I know if the Instant Lighting Discount is the right incentive program to use?** Review your options with your selected distributor or contact our program team at 855-801-5803. We will be happy to help you determine the right choice for you and your business.
- 8 Are new construction projects eligible to receive these incentives?** New construction is not eligible for the Instant Lighting Discount; however, it is eligible through our standard Energy Solutions for Business Program. Visit energysavemd-business.com for more information.
- 9 Can I purchase products for future needs using the Instant Lighting Discount?** No, all lighting sold using this program should be installed with 90 days following the purchase.
- 10 Can I install the lighting myself or do I need to use a contractor?** You may do either. If you hire a contractor to do the work, the contractor could make the purchase at the distributor for you. They would need your Potomac Edison account number, the name and address of the business where the products will be installed, and some contact information. The distributor would then provide your contractor with the new lighting at the reduced price.
- 11 Will there be an inspection of my project?** Potomac Edison and/or its program administrators reserve the right to verify the installation of the products that were purchased by the participant and rebated by the Instant Lighting Discount.
- 12 Can I use the Instant Lighting Discount more than once?** Absolutely. We understand that there are many reasons why you might choose to purchase over time. Feel free to return to the distributor again until all your lighting has been upgraded to efficient LEDs.
