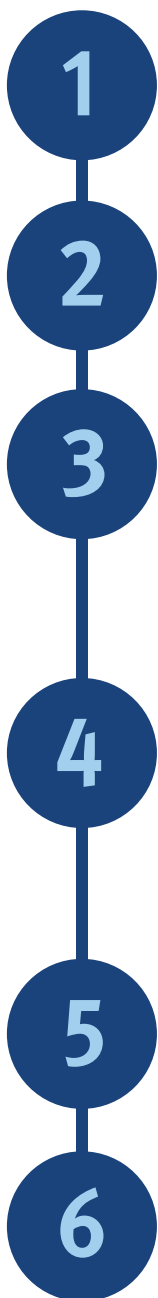


Potomac Edison's Instant Lighting Discounts

Contractor FAQs



<p>1</p> <p>Can I use the Instant Lighting Discount for my customers' projects?</p>	<p>Yes, Maryland Potomac Edison commercial and industrial customers replacing existing lighting with new LED lighting are eligible for an Instant Discount.</p>
<p>2</p> <p>Are new construction projects eligible for these incentives?</p>	<p>No, but new construction projects are eligible for incentives through our standard Energy Solutions for Business Program. Visit energysaveMD-bizsolutions.com for more information.</p>
<p>3</p> <p>What types of lighting projects can I use the Instant Lighting Discount for?</p>	<p>The Instant Lighting Discount is suitable for one-to-one retrofits, typically maintenance and smaller projects. Large projects will be considered; consult your preferred distributor for details.</p>
<p>4</p> <p>What types of lighting products are eligible for the Instant Lighting Discount?</p>	<ul style="list-style-type: none"> • LED High and Low Bay Fixtures • E39 Mogul Base Lamps • LED Linear Fixtures and Retrofit Kits • LED Linear Tubes • LED Exterior Wall Pack and Floods <p>Lighting products must be listed on DLC 5.0 or 5.1, or ENERGY STAR[®] 1.0. Consult your distributor for a comprehensive list of their offerings.</p>
<p>5</p> <p>Can I use the Instant Lighting Discount to purchase inventory for my company?</p>	<p>No, all lighting sold using this program should be installed within 90 days following the purchase.</p>
<p>6</p> <p>Can I purchase products in bulk and use them at different customer locations?</p>	<p>No, purchases must be specific to the location where they are to be installed.</p>

<p>What customer information will I need to provide for the Instant Lighting Discount?</p>	<p>You will need to provide your customer’s Potomac Edison account number, the name and address of the business where the products will be installed and the customer’s contact information.</p>

<p>Can my customer submit for an incentive using the products that I purchased for them using the Instant Lighting Discount?</p>	<p>No, applications cannot be submitted with products that have already received the Instant Discount.</p>

<p>Will my customer be contacted, or will there be an inspection of the project?</p>	<p>Potomac Edison and/or its program administrators reserve the right to verify the installation of the products that were purchased by the participant and included Instant Lighting Discounts.</p>
